With reference to the above cited subject, as per reference (1) the 'Fire Safety Recommendation' was issued from Chief Fire Officer, Bangalore east Zone, Bangalore. to the low rise educational building with compressing of Lower ground, ground and 3 upper floors with the height of 13.60 mtrs.at **"M/s. International School of Business & Research, No.107, Electronics City Phase-1, Behind BSNL Telephone Exchange, Bangalore-560 100."** With a condition to fulfill the recommendations and compliance the same within 3 months.

As per reference (2), (3) & (4) 'Fire Safety Compliance Report' was issued for the same.

With reference cited (5) above, the management of **M/s. International School of Business & Research** had requested for renew the fire safety compliance report from our department. In this regard the above addressed educational building was re-inspected by me on 10-06-2025 for renew the fire safety compliance report.



Under the above circumstance the Karnataka Fire & Emergency Services Department is renewing the **"Fire Safety Compliance Report"** to **"M/s. International School of Business & Research, No.107, Electronics City Phase-1, Behind BSNL Telephone Exchange, Bangalore-560 100."** subject to proper maintenance of fire fighting installations in the good working conditions and **arrange for 40% of staffs/employees training within 03 months from the date of issue of this report.**

In case the fire prevention and firefighting measures installed as per the recommendation of the department are not maintained in good working condition, if the evacuation measures are not properly followed and if any additional construction work is taken up in the building/premises, the Fire Safety Compliance Report deemed to be cancelled and necessary legal action will be initiated against the developer/management/tenant and also separate NOC has to be obtained from the department for the storage of chemicals, solvents, Petroleum products, LPG etc. in the premises/building.

"This Fire Safety Compliance Report is valid for Only Two Years from the date of issue and should be renewed without fail before the validity period".
